

# MELBOURNE ART FAIR 20—23 FEB '25

## TERM AND CONDITIONS OF PUBLIC ENTRY

Welcome to Melbourne Art Fair. We hope you enjoy your visit today. By entering Melbourne Art Fair 2025 (**Show**) owned and delivered by Melbourne Art Foundation Ltd (ABN 76 104 671 589) (**MAF**), each person agrees to be bound by the following Terms and Conditions of Public Entry:

- You must deposit with the Show Cloakroom bags deemed to be large by the Show staff, umbrellas, or any other item, as directed by security; Bag checks may occur at the entry point and any items deemed unsuitable must be disposed of upon request by MAF security staff.
- You must follow all directions and instructions of the staff and security of the Show and the venue.
- You must conduct yourself in a manner which, in the reasonable opinion of MAF, does not interfere with, disrupt, cause injury or offend other persons at the Show. Intoxication, aggressive or anti-social behaviour is unacceptable.
- MAF reserves the right to refuse admission to any person and/or to remove any person from the Show without compensation and without providing any reason.
- No drugs or illegal or dangerous substances or instruments are permitted at the Show. The Show is a licensed event and persons attending Show are also not permitted to bring alcohol to the venue.
- The Show is a non-smoking event. No smoking will be permitted within the event area, including the use of e-cigarettes.
- Persons attending the Show are not permitted to bring animals into the venue, except for Guide Dogs and other registered assistance dogs.
- Children aged 14 years and under must be accompanied by an adult.
- If you attend the Show with children under the age of 18 years, you are responsible for ensuring that they are appropriately supervised and behaved.
- You must leave the Show promptly at or before the scheduled closing time.
- MAF reserves the right to withdraw, substitute or reschedule activities/sessions to be held at the Show at any time without prior notice and you acknowledge that you will not be entitled to any compensation in connection with the same.
- You must not display, distribute or leave any marketing materials, canvas or promote any goods or services to attendees or exhibitors, solicit donations or engage in any commercial or disruptive activity at the Show without MAF's prior written consent which may be given or withheld in MAF's discretion.
- Photography and video filming is permitted if there is no sign prohibiting photography, it does not interfere with or cause concern for other visitors, and does not use tripods, selfie sticks, flash or lighting equipment without prior permission from MAF. Failure to abide by these requirements may result in images being deleted by security staff.
- Official photographers and videographers will be present at the Show. By entering the Show, you consent to you and your child(ren) being filmed and photographed and acknowledge that footage and/or images may be reproduced, published and used by the Show without restriction, including for marketing and promotional use and in all media.
- You acknowledge that you enter Show and the venue at which it is held and participate in the activities offered by MAF at the Show strictly at your own risk. You understand that there are inherent and other risks associated with attending a temporary event and participating in the activities offered by MAF at the Show. You hereby release MAF and its related bodies corporate and their directors, officers, employees, volunteers, contractors, sponsors and/or agents from and against all and any claims, liabilities, losses, damages, costs and expenses to the maximum extent permitted by law in connection with, or as a result of, any loss, injury or damage suffered by you in relation to your attendance and participation in Show, however caused, including any claim or liability which arises due to any negligence by MAF.
- You will indemnify and keep MAF indemnified from all actions, claims, demands, costs, damages or proceedings whatsoever arising from your acts or omissions and/or the acts and omissions of your minor children at the Show.
- You will pay us, on demand, an amount equal to any costs incurred by us in repairing, reinstating or replacing any property damaged by you and/or your minor children at the Show.
